McArdle, 77 A.3d 524, 531 (Pa. 2013) (“Our rules of procedural default provide that failure to raise an issue before the trial court results in waiver for purposes of appellate review.”) (quotation omitted); Commonwealth v. Castillo, 888 A.2d 775, 781 (Pa. 2005) (“The law is settled that it is appellant’s burden to preserve an issue for appeal by including it in his [or her] statement of questions involved.... Thus, an appellant waives all issues not raised in their Statement of Questions Involved and their Brief, regardless of how those issues are phrased or developed in the argument section of the brief.”). In his brief to this Court, Petitioner does not raise an issue regarding the trial court’s application of section 9543.1, nor does he present any argument related to this section. Rather, Petitioner’s entire argument is centered on the issue of the trial prosecutor’s “discriminatory attempt to deprive [Petitioner] of a fair trial.” Petitioner’s Brief at 8. Petitioner raises this issue in the context of the Commonwealth’s alleged “purposeful discrimination” and “premeditated attempts to deny [him] a fair trial.” Id. at 8, 11. However, Petitioner does not pursue this claim in his Pa.R.A.P. 1925(b) Concise Statement of Matters Complained of on Appeal and, thus, he has waived this claim for appellate review. See Castillo, supra; Pa.R.A.P. 2116(a). Accordingly, this Court should affirm the order denying Petitioner relief on his first claim.
